1 Introduction

Female Genital Mutilation (FGM) is an illegal, extremely harmful practice and a form of child abuse and violence against women and girls. The Government is committed to preventing and ending this harmful practice which violates the rights of girls and women.

The Department of Health (DH) in partnership with NHS England launched a FGM Prevention Programme whose aim is to improve the NHS' response to FGM, increase levels of safeguarding for girls at risk of FGM and provide better subsequent support and care for those that have undergone FGM.

Background

As part of the FGM Prevention Programme (2014 – 2018), the Health and Social Care Centre now NHS Digital was commissioned to develop a national FGM Indication System formerly FGM Risk Information System (FGM RIS). This was replaced in 2017/18 by FGM Information Sharing (FGM IS). This is a national IT service and forms part of the national Spine architecture. It allows FGM IS information for children under 18 to be stored and shared with relevant NHS healthcare professionals across departmental, organisational and geographical boundaries within England, supporting effective early intervention and ongoing safeguarding of children potentially at risk of FGM.

Currently, the FGM information held within the FGM IS (an FGM indicator plus assessment date) can only be updated by authorised healthcare professionals using the Summary Care Record Application (SCRa). For healthcare professionals who do not regularly use SCRa this can be cumbersome and time consuming.

The revised ISN Standard DCB2112 updates aligns current and future locally health/care integrated systems to the core system. In addition, mandatory requirements have been reviewed, with local integration functionality currently only mandated in Primary Care settings. It must be noted however that the functionality may be relevant in other health care systems/settings, in which the standard may be applied on a voluntary basis in response to local decision.

Purpose of Document

The purpose of this document is to provide NHS funded healthcare providers in England and their NHS IT systems suppliers with a clear description of the interoperability and functional requirements to access the Spine FGM IS Service from local NHS IT systems to.

2 Objective

The primary objective of allowing FGM IS information on the FGM IS to view/query from local NHS IT systems is to increase access and improve timeliness of FGM IS information to all relevant healthcare professionals thereby supporting the overall objectives of the wider DH FGM prevention programme.

3 Scope

This document applies to NHS funded healthcare providers in England who provide any of the following services along with their NHS IT system suppliers but not excluding other service providers:

- Maternity Services
- Health Visiting
- School Nursing
- · GP Services.

The FGM IS local system integration interoperability requirements cover the ability to:

- Query the Spine FGM IS
- Retrieve data from the Spine FGM IS where a record exists

Access to query the Spine FGM IS can be accessed by an accredited NHS System with appropriate access rights.

- Midwives
- Health Visitors
- School Nurses
- Local Safeguarding Leads
- GP Practice Nurses

All NHS GP practices and their IT system suppliers **must** include this functionality (including 'Out of Hours' services).

NHS acute, community and mental health trusts may also consider which of their local NHS IT systems may incorporate the FGM IS Query / View capability.

This document includes only the **functional business requirements** to enable access to FGM IS Query/Response capability within local NHS IT systems. The technical specifications for the interoperability interactions are defined FGM IS Domain Message Specification vx.x is defined in a separate specification.²

4 Assumptions and Pre-Requisites

- The FGM IS is to be used in conjunction with local safeguarding frameworks and processes. Use of the FGM IS will not change professional responsibilities in this regard.
- A child is identified as being at potential risk of FGM by a clinician following completion of an FGM assessment, as detailed in the Department of Health's best practice guidance³.
- A verified NHS number will be used in the NHS local IT system. A 'verified' NHS number means the patient's identity has been cross-checked using demographic details on the National Spine's Personal Demographics Service (PDS).

5 Requirements

The following are key points for NHS IT systems development:

- Local Spine compliant systems will be able to Query the FGM IS for an FGM indicator associated with a verified NHS number.
- FGM IS only records that a potential family history of FGM exists and the date the FGM assessment was carried out.
- FGM IS information cannot be created for anyone over the age of 18. Note that if a patient has an FGM IS record, then at age 18 this must automatically be deleted by the FGM IS system and will no longer be available to locally integrated systems.
- FGM IS interactions may contain NHS numbers relating to males who have supporting female genitalia. The FGM IS accepts the PDS gender types 'female', 'unknown' and indeterminate'.
- All interactions with the Spine FGM IS will be fully audited within the Spine Core Service in line with existing Spine audit rules.

Keywords

The keywords MUST, SHOULD and MAY are to be interpreted as follows:

• **MUST** - This word, or the terms "REQUIRED" or "SHALL", means that the definition is an absolute requirement of the specification.

- SHOULD This word, or the adjective "RECOMMENDED", means that there may
 exist valid reasons in particular circumstances to ignore a particular item, but the full
 implications must be understood and carefully weighed before choosing a different
 course.
- MAY This word, or the adjective "OPTIONAL", means that an item is truly optional.

Details of how the requirements can be monitored and measured are described in the associated conformance criteria.



6 Local Auditing

Local NHS IT systems MUST keep a clear record of all Interactions submitted to, and responses from, FGM IS in accordance with existing local auditing processes. This is necessary to satisfy any Subject Access Requests (SARs) received by the organisation.


Note that all FGM IS Interactions are centrally audited by Spine.
